The Mandal Educational Officer, Karapa has caused inspection submitted has report in the reference 2<sup>nd</sup> cited to accord permission.

After careful examination of the proposals for opening of classes I to VII from the society and also the inspection report of the inspecting officer in the reference 2<sup>nd</sup> cited and in view of the orders issued in the reference 3<sup>rd</sup> to 4<sup>th</sup> cited, permission is hereby accorded for starting the Educational Institution with Classes I to VII in Green Field International School, Vakada, Karapa (M) during the year 2013 - 2014 without aid from Government subject to following conditions.

1. that the society shall abide to the rules and regulations in the Government order 3<sup>rd</sup> cited above.
2. that the society shall provide the necessary amenities like Accommodation, Sanitary facilities, Drinking water facilities, Furniture, Library, Laboratory equipment, Play field required staff as per the staff pattern and other facilities are necessary before approaching the competent authority.
3. that the society shall apply for recognition by 31<sup>st</sup> October at the latest duly fulfilling the conditions.
4. that the permission accorded is restricted to this year end and it is not valid for the subsequent academic year.
5. that this permission does not confer any right on the society for claiming recognition.
6. that the permission is accorded to Sri Dhana Lakshmi Educational Society and no other society or body can open a school on their behalf.
7. the permission is accorded to open the school premises in the locality and there shall not be any change in the premises in locality.
8. the society shall provide the necessary material even it can more than the deposit amount.
9. subject to fulfillment of all conditions as per G.O.Ms.No 1 End, dt. 01-01-1994, G.O.Ms.No 41 Edn, dt. 11-05-2006 and G.O.Ms.No 74 Edn, dt. 11-09-2006.
10. The Opening permission now granted subject to production of Registered Lease Deed/Ownership Deed in the name of the Society along with the proposals of Recognition.
11. The Management should submit the following documents while submission of proposals for according provisional recognition.
  - a) Structural soundness Certificate issued by the competent authority.
  - b) Sanitary Certificate issued by the competent authority.
  - c) Strength particulars
  - d) Staff particulars
  - e) No Objection Certificate from the Traffic Police
  - f) Endowment fund pledged with the District Educational Officer, East Godavari, Kakinada
12. The Management should complete the construction of building before commencement of academic year 2013-14
